**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER IX
ENTITLED "RECREATIONAL FACILITIES" OF THE REVISED
GENERAL ORDINANCES OF THE TOWNSHIP OF MAHWAH,
SPECIFICALLY CHAPTER IX SECTION 1.4 ENTITLED "UNLAWFUL
USE", SUBSECTION B.**

WHEREAS, the Township of Mahwah desires to amend and supplement the provisions of Chapter IX, Section 1.4 of the Mahwah Revised General Ordinances to include an additional recreation facility; and

WHEREAS, the Township Council of the Township of Mahwah has determined that this addition would be in the best interest of the citizens of the Township of Mahwah.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Mahwah as follows:

Section 1. Chapter IX, Section 1.4, entitled "Unlawful Use", Subsection B of the Mahwah Revised General Ordinances shall be amended and supplemented as follows:

- B. During such times that a licensed concession stand is open for business, no person shall engage in hawking, peddling, or vending of any foods, beverages or confections of any nature or description in Continental Soldiers Park and/or Commodore Perry Field.

Section 2. All other definitions, parts, portions and provisions of Chapter IX, "Recreational Facilities", Section 1.4, "Unlawful Use" which are not inconsistent herewith, are ratified and confirmed. In the event of any such inconsistencies, the terms and provision of this Ordinance shall govern.

Section 3. If any section, paragraph, sub-section, clause or provision of this ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this ordinance as a whole or any part thereof.

Section 4. All ordinances or parts of ordinances of the Township heretofore adopted that are inconsistent with any of the terms and provisions of this ordinance are hereby repealed to the extent of such inconsistency.


Section 5. This Ordinance shall take effect twenty (20) days after final passage, adoption and publication according to law.


