ORDINANCE NO. 1805  
AN ORDINANCE TO AMEND SALARY ORDINANCE #1794**

WHEREAS, the Township of Mahwah establishes salary ranges for all employee salaries; and

WHEREAS, the Township of Mahwah has approved collective bargaining agreements with the Mahwah Police Benevolent Association, the UPSEU White Collar Unit and the UPSEU Blue Collar Unit; and

WHEREAS, the Township of Mahwah establishes salary ranges for non-union employees in accordance with the related collective bargaining unit ranges; and

WHEREAS, the Township of Mahwah 2017 Municipal budget provides funding for the positions listed below;

NOW, THEREFORE BE IT ORDAINED by the Township Council of the Township of Mahwah that Salary Ordinance #1794 be amended as follows:


1. Except where indicated in #2 below, this Ordinance shall become effective as provided for by law and shall be implemented retroactively to January 1, 2017.

3. All other provisions of Ordinance No. 1794 shall remain unchanged.


