TOWNSHIP OF MAHWAH  
ORDINANCE NO. 1804

AN ORDINANCE AMENDING CHAPTER 7 "TRAFFIC" OF THE REVISED  
GENERAL ORDINANCES OF THE TOWNSHIP OF MAHWAH" SECTION 7-9  
"BUS STOPS" DESCRIBING LOCATIONS DESIGNATED AS BUS STOPS

WHEREAS, the Township of Mahwah desires to amend and supplement the provisions of Chapter 7 "Traffic" of the Mahwah Revised General Ordinances, Section 7-9, Schedule XIII "Bus Stops".

NOW THEREFORE, BE IT ORDAINED by the Township Council of the Township of Mahwah as follows:

Section 1. Chapter 7 "Traffic", §7-9, Schedule XIII "Bus Stops" is deleted in its entirety and replaced with the following:

§7-9, Schedule XIII Bus Stops:

Pursuant to N.J.S.A. 39-4-8(e), the following described locations are designated as bus stops:

MAHWAH COUNTY ROADS

1. Along Franklin Turnpike (CR 507), northbound on the easterly side thereof
  - (a) Between Orchard Street and Bellgrove Drive (mid-block) (prolongation)  
Beginning 300 feet south of the southerly curb line of Bellgrove Drive and extending 120 feet southerly therefrom (location 12566).
  - (b) Industrial Avenue (near side) (prolongation)  
Beginning 100 feet south of the southerly curb line of Industrial Avenue and continuing 120 feet southerly therefrom (location 12567).
  - (c) Micik Lane (near side)  
Beginning adjacent to the southerly curb line of Micik Lane and continuing 120 feet northerly therefrom (location 12568).
  - (d) Airmont Road (near side)  
Beginning at the southerly curb line of Airmont Road and extending 105 feet southerly therefrom (location 12569).

- (e) King Street (near side)  
Beginning at the southerly curb line of King Street and extending 105 feet southerly therefrom (location 12570).
- (f) Miller Road (near side)  
Beginning at the southerly curb line of Miller Road and extending 105 feet southerly therefrom (location 12571).
- (g) Lawrence Road (far side) (prolongation)  
Beginning at the prolongation of the northerly curb line of Lawrence Road and extending 100 feet northerly therefrom (location 12572).
- (h) Between Stephens Lane and Cedar Hill Avenue (mid-block)  
Beginning 300 feet north of the northerly curb line of Stephens Lane and extending 135 feet northerly therefrom (location 12573).
- (i) Cedar Hill Avenue (near side)  
Beginning at the southerly curb line of Cedar Hill Avenue and extending 105 feet southerly therefrom (location 12574).
- (j) Fox Lane (near side)  
Beginning at the southerly curb line of Fox Lane and extending 105 feet southerly therefrom (location 12575).

2. Along Franklin Turnpike (CR-507), southbound on the westerly side thereof

- (a) Between Fox Lane and US 202 (mid-block) (prolongation)  
Beginning 60 feet north of the prolongation of the northerly curb line of Fox Lane and extending 135 feet northerly therefrom (location 12578).
- (b) Cedar Hill Avenue (far side) (prolongation)  
Beginning 50 feet south of the southerly curb line of Cedar Hill Avenue and extending 100 feet southerly therefrom (location 12579).
- (c) Stephens Lane (near side) (prolongation)  
Beginning at the prolongation of the northerly curb line of Stephens Lane and extending 105 feet northerly therefrom (location 12580).
- (d) Lawrence Road (far side) (prolongation)  
Beginning at the prolongation of the southerly curb line of Lawrence Road and extending 100 feet southerly therefrom (location 12581).

Section 2. All other parts, portions and provisions of Chapter 7 of the Township of Mahwah Code, be and the same, are hereby ratified and confirmed, except where inconsistent with the terms thereof. In the event of any such inconsistency, the terms of this Ordinance shall be deemed to govern.

Section 3. If any section, paragraph, sub-section, clause or provision of this ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this ordinance as a whole or any part thereof.

Section 4. All ordinances or parts of ordinances of the Township heretofore adopted that are inconsistent with any of the terms and provisions of this ordinance are hereby repealed to the extent of such inconsistency.

Section 5. This Ordinance shall take effect twenty (20) days after final passage, adoption and publication according to law.


