**TOWNSHIP OF MAHWAH  
ORDINANCE NO. 1838**

**AN ORDINANCE AMENDING AND SUPPLEMENTING THE  
REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF  
MAHWAH, CHAPTER IX "RECREATIONAL FACILITIES"  
SECTION 9-1.9 "MEMBERSHIP" SUBSECTION (A) "MEMBERSHIP FEES"  
AND SECTION 9-1.10 "RECREATION FEES"**

NOW THEREFORE, BE IT ORDAINED by the Township Council of the Township of Mahwah, as follows:

Section 1. Chapter IX "Recreational Facilities" of the Revised General Ordinances of the Township of Mahwah, Section 9-1.9 "Membership" Subsection (A) is hereby amended and supplemented in its entirety, as follows:

§9-1.9 Membership for Municipal Swimming Pool

(A) Membership fees for annual memberships are established as follows:

**Municipal Swimming Pool Membership**

Emergency Services: Fire, Ambulance, OEM Operational Members	\$100.00 per Family

Resident, Family membership (two adults and children)	\$400.00
Resident, Single Family membership (one adult and child)	\$275.00
Resident Adult	\$150.00
Resident Teenager ages 13-18	\$125.00
Resident Senior (65+)	\$45.00
<b><u>Non-Resident</u></b>	
Non-Resident Family membership (two adults and children)	\$525.00
Non-Resident Single Family membership (one adult and child)	\$300.00
Non-Resident Adult	\$225.00
Non-Resident Teenager ages 13-18	\$225.00
Non-Resident Senior (65+)	\$100.00
<b><u>Guest Passes With Member</u></b>	
Adult	\$15.00
Child	\$10.00
Senior (65+)	\$5.00
<b><u>Guest Pass Cards Book of 10</u></b>	
Mahwah Residents	\$75.00
Non-Resident	\$75.00

Food Truck Festival/Participant Fee

Up to \$5.00/person

The above fees may be changed by the Township Council on a yearly basis pursuant to resolution.

**Section 3.** All other parts, portions and provisions of Chapter IX of the Township of Mahwah Code, be and the same, are hereby ratified and confirmed, except where inconsistent with the terms thereof. In the event of any such inconsistency, the terms of this Ordinance shall be deemed to govern.

**Section 4.** If any section, paragraph, sub-section, clause or provision of this ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this ordinance as a whole or any part thereof.

**Section 5.** All ordinances or parts of ordinances of the Township heretofore adopted that are inconsistent with any of the terms and provisions of this ordinance are hereby repealed to the extent of such inconsistency.


**Section 6.** This Ordinance shall take effect twenty (20) days after final passage, adoption and publication according to law.




