

**TOWNSHIP OF MAHWAH
ENVIRONMENTAL COMMISSION MEETING MINUTES
WEDNESDAY, MARCH 13, 2019**

The meeting of the Environmental Commission, held at the Municipal Building, 475 Corporate Drive, Mahwah, New Jersey, was called to order at 7:33 p.m. by Richard Seibert, Vice Chair. The Opening Statement was made. Roll call was taken.

The minutes of the meeting held on February 27, 2019 were approved as submitted following a motion by Seibert; seconded by LaGreca. Ariemma abstained. All other present members were in favor.

OLD BUSINESS

Repair Café Presentation

Tanja Israel and Maiken DuBois (80 Youngs Road) are spearheading a new Repair Café initiative in town. Repair Café is a Dutch initiative started in 2009 in a theatre; today there are approximately 1,800 all over the world (120 in the United States, two of which are in New Jersey (Summit and South Orange)). This is a free community initiative where individuals can bring in broken items and volunteers fix them free of charge. Volunteers are on hand to fix clothing, furniture, electronics, jewelry and much more. Israel said there is an event in Warwick this Saturday from 10 a.m. to 2 p.m.

Israel is working on a Repair Café in Mahwah and would like support and ideas from the town. She said finding a good location in town is her first priority. This is a great garbage-diminishing initiative that encourages people to reuse and recycle things to reduce waste.

Members discussed potential upcoming events including our Recycling Forum on October 15 and Mahwah Day; as well as possible locations such as the Mahwah Library and Ramapo College. Israel is going to reach out to the Senior Center and Ramapo College. We will put together an additional list of locations and resources.

Tree Giveaway – Saturday, April 13, 2019

Our Tree Giveaway is scheduled for Saturday, April 13 from 9 a.m. to 12 p.m. We need to coordinate the pickup of trees with DPW. Members discussed their responsibilities.

LaGreca will prepare a flyer to share with Ariemma, who will post on the town's cable channel. LaGreca will post on our Facebook page. Wolf will ask Deb Burns to post the information on the town website.

Recycling Update

Our Recycling Forum is scheduled for Tuesday, October 15, 2019 from 7 p.m. to 8:30 p.m. Kerry Scales, a representative from Rockland County Solid Waste Management Authority, will speak and show a video during the forum. LaGreca gave an update on the status of Tom McKeon's work. The boy scouts are on board to help out with a large electronics disposal event. McKeon is presenting to a group of senior citizens on March 21. Members discussed other potential speakers and topics.

Stag Hill Tire Cleanup

Pallotta reached out to the Bergen County Utilities Authority regarding organizing a tire collection in conjunction with the county's June 8 hazardous waste collection. The county has informed him that they are not able to collect the additional tires from Stag Hill. They suggested we apply for a 2019 Recycling Enhancement Grant from the Bergen County Utilities Authority. Pallotta submitted.
