Chair's Report:

Crocker Mansion: The Chair reported that she will print out and present to Mrs. Greene the pictures she and Mrs. Shanley took of the Crocker Mansion tour they attended.

Bergen County Historic Grant: no report at this time.

CLG Grant: The Chair reported that the CLG Grant is a non-matching grant of up to \$24,000. The Chair spoke with Mahwah Museum Trustee members, Mr. & Mrs. Robert Adler regarding the Museum's interest in applying for the Grant under the sponsorship of the HPC. The grant application would include new signage for the Train Station Museum and the other structures, and repairs to the Caboose. The HPC would apply for the CLG Grant on behalf of the Mahwah Museum. The application is due by January 19, 2017. Mrs. Beatrice and Mrs. Cuman volunteered to assist the Chair with the application and Mr. Wohlberg volunteered to assist with the budget for the project.

Committee Reports:

Moffatt Road Cemetery: Mrs. Grob reported that she will contact the Tax Assessor to obtain the name of the property owner of the adjacent property facing Route 17 North.

Vanderbeck Cemetery: No report at this time.

Carmelite Retreat: The Chair confirmed that the Carmelite Retreat has been sold to a Rehabilitation Center. Mrs.

Powley will research the name of the owners.

Darlington School House: No report at this time.

Mahwah Museum: No further report at this time.

Quackenbush Barn: Mrs. Powley reported that Wallace Trucking will donate ¾" or larger gravel for around the base of the Quackenbush Barn. Mrs. Powley will contact, DPW Buildings and Grounds Foreman, Tony Iannaconne, to schedule delivery and distribution of the gravel.

Applications: Docket #588, 38 N. Railroad Avenue, Minor Subdivision. It was determined that this property has no historic significance and that the Chair will sign off on the application, with request that the HPC be allowed to take photos of the property before the house is demolished.

New Business: Mr. Vasiliadis asked if the HPC should consider refurbishing some of the older historic markers. The secretary will contact the company that made the signs, Sewah, and ask what the cost would be and the best way to refurbish them.

Mrs. Powley moved to adjourn the HPC meeting and Mrs. Cuman seconded the motion. All approved.
