WHEREAS, N.J.S.A. 40A:14-118 provides that a municipality may provide by ordinance for the Appointment of a Chief of Police who shall be the Head of the Police Force, and the Township of Mahwah by Township Code Section 2-9.1 has established a Department of Police the Head of which is the Chief of Police, and

WHEREAS, under N.J.S.A. 40:69A-43(b) and Township Code Section 2-4.4.a, department heads are appointed by the Mayor with the advice and consent of the Township Council, and

WHEREAS, under N.J.S.A. 40:69A-36.b, the Township Council by resolution exercises its power of advice and consent to actions of the Mayor, and

WHEREAS, the Mayor has informed the Township Council that he has appointed Captain Stephen Jaffe as Chief of Police of the Mahwah Police Department, effective immediately upon the Police Chief completing the Oath of Office.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Mahwah that the Township Council does hereby give its advice and consent to the appointment of Stephen Jaffe as the Chief of Police of the Mahwah Police Department.
