Motion to open the meeting to the public was made by Mr. Ervin, seconded by Mr. Donigian and declared unanimously carried by Mr. Crean.

Mr. John Fesen of 20 Falcon Court spoke of the following questions and/or concerns:

- Mr. Fesen referred to the last Planning Board meeting when he discussed a Board of Adjustment meeting in Chestnut Ridge, NY. He stated that he emailed a link of the meeting to Mr. Sherer and asked if the Board had received the link. They had not. Mr. Fesen then gave a copy of his email to all the Board Members. He invited Members to join him at the next Chestnut Ridge Board of Adjustment meeting. Mr. Fesen voiced the question again, asking if this situation can occur in Mahwah. As discussed at the prior meeting, Mayor Laforet stated that the Township reviews every application that is submitted. Mr. Kelly recommended that all correspondence from the public be presented to and filtered through the Planning and Zoning Administrative Officer. Communication can then be documented and uniformly provided to the Planning Board Members.
- Mr. Fesen would like to know what happens in a situation when there is no record of information for a zoning approval. He discussed a situation about a private school in the Village of Airmont. They cannot find a record of the number of students that should be in attendance. Mr. Kelly explained that any application is clearly documented in the plans, application and testimony.
- Mr. Fesen voiced concern about the decibel level of any gun range modifications. He asked if there was a baseline decimal level. Mayor Laforet stated that it is a County property. The Township may recommend decibel levels but we cannot enforce it. Mr. Kelly believes the Township's intent is to bring concerns to the County's attention. Mahwah's Administrative Zoning Office has requested that the County appear as a courtesy, to present what their plans are. Mr. Kelly said there are State standards. It was suggested that Mr. Fresen address his concerns as a Bergen County citizen at the County Board of Freeholders meeting.
