The Meeting was called to order at 8:05PM by Council President Roth who read the Open Public Meetings Act Statement as prescribed by law. Martel Municipal Offices, 475 Corporate Drive, Mahwah, New Jersey on Thursday, April 28, 2016 at 8:00PM.

MOMENT OF SILENCE FOR VETERANS AND THOSE SERVING IN THE MILITARY

Moment of Silence was observed for those who served and those who are serving in the military both here and abroad. It is because of their valor and bravery that we can hold meetings such as these.

PUBLIC PORTION

On a motion by Hermansen, seconded by Sbarra, the meeting was opened to the public at 8:06PM. All in favor. Motion carried.

Mrs. Kate Nunez of 14 Long Avenue said she has attended Council Meetings previously and spoke about the traffic in West Mahwah. She said she started bringing the problem to the attention of the Township in 2014 and nothing is in place. She continued that summer is approaching and those in the area will be faced with increased traffic, etc. She asked the Council to put in intervention before the summer begins. Roth said he would address the matter further with the Township Engineer and Township Attorney. Hermansen said the Township in the past offer a solution to the problem but the residents in the area were not in agreement with it. He suggested everyone sit down and work together.

Mr. Jonathan Marcus of 3 Brook Court said it was a great day on Saturday. All of the 1,000 trees were given out in 2 hours. He thanked the DPW for their help. Next year, 2,000 trees will be requested. They have been told the more trees requesting the more species of trees received.

Mr. Marcus said the Environmental Commission received a response to the letter to the FAA on the change in the Flight Pattern. The FAA has said that before making a new Flight Path permanent they will embark on environmental studies.

1a. Bolla Mahwah Realty Corporation; 130 Route 17 South; Block 129, Lot 1; Request for Reduction of Performance Guarantees (Docket #522 PF)

The Township Engineer's Associate said this item is a recommendation for a performance guarantee reduction at 130 Route 17 South. A few items remain outstanding which must be addressed by July 14, 2016. Resolution shall be voted on in the Public Meeting.

2016 Road Program: in the final stages of the design. Expect to Award the Bid at the Meeting after next.

Ariemma said she was contacted by a resident about the No Parking signs on Island Road. The resident said the signs make it appear that there is no parking in between the signs. Suggestion was made to post No Parking signs near corners. The Township Engineer's Associate will go out to the site and report back to Council.

2016 BUDGET PRESENTATION

Mr. Ken Sesholtz, Township Chief Financial Officer and Mr. Lou Mai, Township Auditor were present.

The Business Administrator explained the Budget Analysis summarizes the Budget. The Mayor as the Chief Executive Officer of the Township presents the Budget to the Council.

The two parts of the Budget are the Revenue side where taxes are the majority of the money and the Appropriations side where the money is spent.

The Business Administrator went through the Budget Analysis document. He stated the two CAP Laws that we are required to comply with that restrict the money to be spent are the CAP Levy and the Spending CAP (COLA). The Municipal Tax Rate increased \$.004 from 2015 to 2016 equating to an increase to the average homeowner of \$19.00. Ratables are up this year.

In the Public Meeting, the 2016 Municipal Budget shall be voted on.

2a. Authorization to Demolish Structure and Funding; 56 Eastview Drive; Block 12, Lot 39 The Township Attorney said the request was made by the Township Construction Official to demolish the structure at 56 Eastview Drive as it was deemed unsafe, unsanitary, a fire hazard and in danger of collapsing. The funds expended on the property will be a lien against the property. Resolution shall be voted on in the Public Meeting.
