writing by the Township of Mahwah, **I agree to furnish a Certificate of Insurance specifically  
naming the Township of Mahwah as an additional insured providing general liability,  
bodily injury and property damage coverage with minimum limits of liability not less than  
\$1,000,000 combined single limit. Said certificate shall state that "the issuing company shall  
mail any change or cancellation with 30 days written notice to the certificate holder named,  
certified mail, return receipt". It shall also contain a statement acknowledging this hold  
harmless agreement. No exceptions or limitations will be accepted.**

The novel coronavirus, commonly known as COVID-19, has been declared to be a worldwide pandemic by the World Health Organization (WHO). SARS-CoV-2 (the virus that causes COVID-19) and the related illnesses and medical conditions called COVID-19 and Multi-System Inflammatory Syndrome in Children (MISC) are extremely contagious. They are believed to spread primarily through close person to person contact, even with asymptomatic individuals. There is no known vaccination(s), immunization(s) or cure for these pandemic illnesses.

Recently, however, as the number of cases continue to decline Statewide, the Governor issued Executive Orders 149 & 157, which allows for various outdoor activities, including recreational activities, summer camp and outdoor pool operations to resume under certain conditions on or after June 22, 2020. With the reopening of these activities, the Township of Mahwah has implemented a number of preventive measures to reduce the spread of COVID-19.
